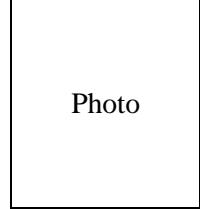

RULES FOR GUIDANCE OF CANDIDATE

1. Candidate will be required to present with original photo identity.
2. The examination will be held on date as per programme notified.
3. During the course of examination, the candidates shall be under the discipline of the Center Superintendent and shall obey the orders on all the matters related to the examination.
4. Examinees shall be required to use the urinals provided by the center only. Smoking, use of intoxicants and communication gadgets (Pages, mobile, cellular phone) in Examination center is strictly prohibited.
5. Invigilators and members of the flying squad are empowered to take search of the examinees during the examination.
6. Attempt to use unfair means to pass the examination or found guilty of use of unfair means or disorderly conduct at/or in connection with the examination or any violation of preceding rules or any personal approach to the examiner concerned will be liable to severe penalty under provisions of unfair means. Such candidate will be asked to submit their written statement in the printed proforma to be supplied by the Center Superintendent in the Examination Hall. If the candidates refuses to give their statement on the spot and/or refuses to sign the Material recovered or leaves the Center without giving their statement or if they are guilty of showing disorderly conduct, notice will be sent to them for using unfair means and/or showing misconduct. However, if they run away with the incriminatory material, their case will be decided by the University in absentia on the basis of the report of the invigilator /Center Superintendent and the reply, if any, received from the candidates and no representation or protest from them will be entertained afterwards.
7. Order of Hon'ble Supreme Court will be applicable in any case of unfair means.
8. If a candidate/candidates boycott(s) any paper/examination, it shall be at their own risk. Complaints against question paper if any, should be submitted to the University through the Center Superintendent concerned within 24 hours from the date of Examination for the paper concerned, after which, no complaints will be entertained. Grievance Committee has been constituted to look into the grievances and take appropriate action there after.
9. A candidate will not be allowed to leave the Examination hall before completion of Examination.
10. The jurisdiction for disputes will be Udaipur City only.
